

APPLICATION TO EXHIBIT AT THE BOSVELD FESTIVAL BELA-BELA 30 APRIL 2016 Forever Resort Bela-Bela Feesterrein

- 1. Please note that only persons that applied and were given permission will be allowed to erect a stall at the festival.**
- Every exhibiter is responsible for erecting his/her own structure (Gazebo/tent/tables/chairs/etc.) on the stand allocated by the organizers.
- Structures must be safe and must not pose a hazard to yourself and others.
- No water will be supplied to the stands but is available on the premises and electricity can be provided on request.
- Each exhibiter is responsible for their own accommodation (not on the premises). Contact Forever Resorts Warmbaths for accommodation at +27 (0)14 736 8500.
- No vehicles will be allowed in the stall area after 08:00 or before 17:00. Stalls must be erected and ready before 08:00 on 30th April 2016 and in operation till at least 17:00. Stalls can be erected the previous day from 14:00 .
- 7. Admission for the public to the Bosveldfees is a R10 donation per adult and children are free. All the admission fees will be allocated to the OSR which is also a children welfare organization.**
- Exhibiters may only sell or display products as stipulated in the application form.
- Exhibiters are not allowed to make or sell any food or drinks on the premises during the festival.
- The organizers have the right to decline any application for reasons that is in the interest of the Bosveldfees and other exhibiters.
- Stands will be allocated on a first come first serve basis.
- Costs per stand is **R500**
